DRA professionals play critical roles throughout the healthcare product life cycle, from concept through product obsolescence.
- Therefore, there is an enormous demand of DRA professionals owing to continuous evolution in science and changes in the regulatory environment, health sector and general economics, which has shaped the dynamic and expanding scope of the regulatory affairs professionals.

- Pharmaceutical Packaging is a much specialised area with its own unique issues and problems. Packaging is a critical tool in the pharmaceutical industry for product delivery and regulatory compliance. Rising stringent regulations, marketing strategies, supply chain issues, anti-counterfeiting tactics and increasing awareness about importance of packaging in pharmaceutical has led to rising demand of skilled packaging professionals.
- Pharmaceutical packaging requires a greater knowledge of materials and a greater intensity of testing than most other packed products, not to mention a sound knowledge of pharmaceutical products and an understanding of regulatory requirements. practical models and case studies and exercises at each level of understanding.
- ISAPS offers specially designed course which provides an assessment of a wide range of entire supply chain from conversion of raw materials into packaging materials and then assembled into product packs. Integrating information from many drug delivery systems ,the course discusses testing, evaluation and other important aspects of pharmaceutical packaging.

Pharmacovigilance

- Pharmacovigilance (PV) is the pharmacological science relating to the detection, assessment, understanding and prevention of adverse effects, particularly long term and short term side effects of medicines.
- It is also known as the monitoring and assessing of responses to pharmaceuticals to detect and prevent adverse effects.
- Entry level job in Pharmacovigilance is DSA (Drug Safety Associate). DSAs are mainly involved in case creation, checking for MSI (Minimum safety information – a patient, a reporter, a suspect drug and a adverse event), reconciliation and follow-up process, data entry of all information available in the document and medical coding.

Pharmaceutical Production Management

- Pharmaceutical Production Management is the branch of Pharmaceutical industry which ensures the effective and safe use of pharmaceutical drugs. It is conceptualized with vision to create effective Production Manager for specifically for handling pharmaceutical formulation plant. This course gives practical knowledge of functionalities of production related jobs/decision making skills. Industrial production managers are responsible for production schedule and staffing, procurement and maintenance of equipment, quality control and coordination of production activities among different departments.
- ISAPS offers specially designed course which discusses the role of Production Manager for manufacturing and use of safer drugs. The requirements of Standard Operating Procedures (SOPs), Batch Processing Records, Quality Control Records and Logs are discussed and the knowledge necessary to meet current regulatory expectations are developed. This course provides explanation and examples of the key documents, required for pharmaceutical development, manufacturing processes and laboratory testing. The course provides a practical approach to master formula, batch records and laboratory controls and validation requirements.

Management of Drug Medical Store
